## Joint Base Pearl Harbor Hickam F-22 Plus Up Environmental Assessment

The Department of the Air Force (DAF) announces the availability of the Draft Environmental Assessment (EA) and Draft Finding of No Significant Impact (FONSI)/Finding of No Practicable Alternative (FONPA) for the integration of seven F-22A Raptors from Tyndall Air Force Base into the existing fleet of the Hawaii Air National Guard (HIANG) 199 Fighter Squadron (199 FS) and construction actions to meet current mission requirements at Joint Base Pearl Harbor Hickam (JBPHH), Honolulu, Hawaii.

The Proposed Action is to increase the number of F-22A assigned aircraft to the HIANG's 199 FS from 18 Primary Aerospace Vehicles Authorized (PAA) plus 2 Backup Aircraft Inventory (BAI) to 24 PAA plus three 3 BAI. The purpose of the Proposed Action is to integrate the seven additional F-22A aircraft into the 199 FS current fleet. The Proposed Action would also include construction projects, as well as repair and renovation projects, within the HIANG lease area on JBPHH.

The Draft EA and Draft FONSI/FONPA are available for public review and comment for 30 calendar days, beginning August 25, 2025. Written comments must be postmarked or emailed no later than 11:59 p.m. Eastern Time (ET) on September 24, 2025, for consideration in the Final EA. The public may submit written comments to:

Do not include any PII within the text of your comment (e.g., name, address, social security number, email address, telephone number, etc.).

\* Substantive comments are regarded as those comments that challenge the analysis, methodologies, or information in the Draft document as being factually inaccurate or analytically inadequate; identify impacts not analyzed or identify reasonable alternatives or feasible mitigations not considered by the

agency; or offer specific information that may have a bearing on the decision such as differences in interpretations of significance, scientific data, or technical conclusions.
